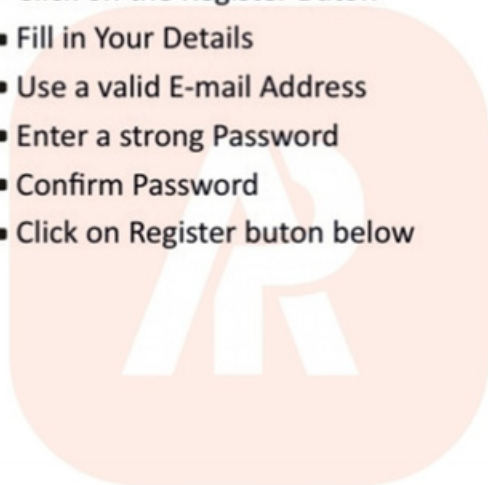

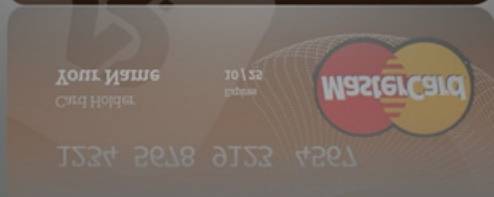

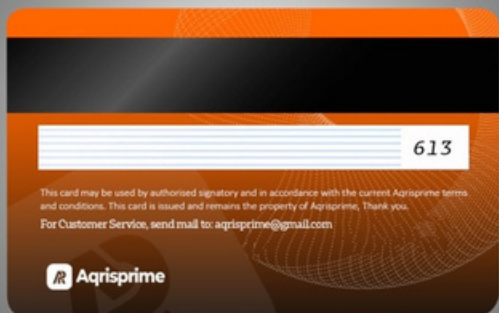
The Aqrisprime financial protocol is what keeps the system stable for long term productivity and workability. Following the protocol requirements all Aqrisprime hybrid compounding portfolios are obligated to be connected to the protocol's Virtual card system for 100% efficiency and server optimization.



## WHY THE VIRTUAL CARD IS COMPULSORY FOR HYBRID COMPOUNDING ACCOUNTS

- 1. Security:** Large amounts of financial data is transferred across our hybrid servers on a daily basis, and if compromised by any slightest margin, will lead to catastrophic results for our platform. With the Zero Trust Security Model, our virtual card provides user level security clearance for every command initiated by each user for any transaction on the Aqrisprime system. This is important for the protocol
- 2. Data Analysis:** Each user data is processed per trade cycle for insurance purposes, and the unlimited trade data in hybrid accounts can only be tracked with the help of a TMS, under the Mastercard and Paypal protocols, which are the major hosts for our virtual card system.
- 3. Speed:** Following transactions of huge financial data on hybrid protocols, there is bound to be a lag in server traffic during deposits and withdrawals as witnessed by members in the past. Our virtual card private key system ensures a decentralised format of command confirmations which speeds up the data processing system for faster command confirmations.



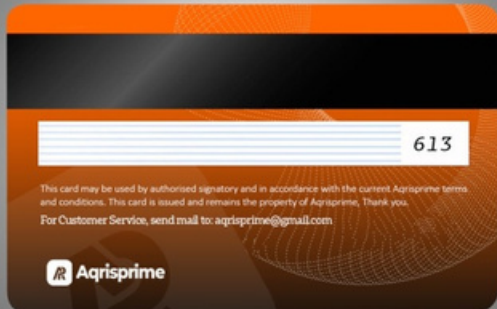
